  - Inhumane treatment of a horse in a stall, runway, school area, show ring, or elsewhere on the event grounds by any person.Any action(s) against a horse by a competitor or an exhibitor which are deemed excessive by Horse Show/Clinic Management, in the ring or anywhere on the competition grounds may be punished by warning or elimination, as deemed appropriate by the Management.
